

LightFair/IALD Immersive Lighting Installation Design Contest Official Rules

1. **HOW TO ENTER.** Register to participate at lightfair.com. Winning entries will be selected by IALD. If selected, cost to participate is \$5,500. Contest begins Monday, October 31, 2022 and ends Tuesday, May 23, 2023 (the "Contest Period"). Eligible manufacturers may enter by: Thursday, November 10, 2022, during the Contest Period.
2. **WHO MAY ENTER.** Contest is open to commercial and architectural lighting manufacturers. Employees of LightFair (LF), its partners, and their respective affiliates (as well as members of the same household as such employees) are not eligible to participate or win. Selected manufacturers will be paired with a lighting design agency at random.
3. **SELECTION OF WINNERS.** One (1) winning manufacturer-designer team will be selected by judges from IALD based on the following: (i) Interpretation and response to the creative brief; (ii) Quality of the installation; and (iii) Composition and design of the installation. The Winner will be selected on Tuesday May 23, 2023. The judges' decisions concerning all matters related to the contest shall be final.
4. **PRIZES.** Odds of winning will depend upon the number of eligible installations at LightFair 2023. Prizes are non-transferable. Winners are responsible for all tax liabilities and expenses not expressly provided for above. LF makes no representations or warranties as to the Prizes, and the winners accept the Prizes "as is." Winners are responsible for the reporting and payment of all federal, state, and local taxes (if any). The Approximate Retail Value ("ARV") of the Prizes is less than \$7,500.
